RESOLUTION NO. 9 - 2021

"A RESOLUTION APPROVING SPECIAL EDUCATION FUND (SEF) SUPPLEMENTAL BUDGET NO. 4 FOR THE CALENDAR YEAR 2021 OF THE PROVINCE OF DAVAO DE ORO AMOUNTING TO FIVE MILLION PESOS (\$\frac{1}{2}5,000,000.00) ONLY FOR PRIORITY EDUCATION PROGRAMS, PROJECTS AND ACTIVITIES IN THE PROVINCE."

WHEREAS, Ms. Eva Jean S. Licayan, Provincial Budget Officer, presented and discussed to the Local School Board the possible source of fund and the corresponding appropriation for the Supplemental Budget No. 4 - CY 2021 of the Special Education Fund (SEF) amounting to Five Million Pesos (P5,000,000.00);
