"A RESOLUTION APPROVING SPECIAL EDUCATION FUND (SEF) SUPPLEMENTAL BUDGET NO. 1 FOR THE CALENDAR YEAR 2022 OF THE PROVINCE OF DAVAO DE ORO AMOUNTING TO THIRTEEN MILLION SEVENTY TWO THOUSAND NINE HUNDRED SEVENTY NINE PESOS AND 6/100 (\$13,072,979.06) ONLY FOR PRIORITY EDUCATION PROGRAMS, PROJECTS AND ACTIVITIES IN THE PROVINCE."

WHEREAS, Mr. Ariel D. Mandawe, OIC - Provincial Accountant, presented and discussed to the Local School Board the Computation of Funds Available for Appropriation (Beginning Balance) as of December 31, 2021 as well as the Certification signed by the OIC - Provincial Accountant, Provincial Budget Officer and the Acting Provincial Treasurer for the Supplemental Budget No.1
