"A RESOLUTION APPROVING SPECIAL EDUCATION FUND (SEF) ANNUAL BUDGET FOR THE CALENDAR YEAR 2022 OF THE PROVINCE OF DAVAO DE ORO AMOUNTING TO THIRTY FIVE MILLION PESOS (\$\frac{1}{2}35,000,000.00) ONLY FOR PRIORITY EDUCATION PROGRAMS, PROJECTS AND ACTIVITIES (PPAs) IN THE PROVINCE OF DAVAO DE ORO"

WHEREAS, Ms. Eva Jean S. Licayan - Provincial Budget Officer presented the Certification from the Provincial Treasurer's Office for the probable Provincial Share from the additional one percent (1%) of collections from real property taxes known as Special Education Fund (SEF) for the Calendar Year 2022 of Thirty Five Million Pesos (\$\mathbb{P}\$35,000,000.00);
