

### RESOLUTION NO. 19 - 2023

"A RESOLUTION APPROVING SPECIAL EDUCATION FUND (SEF) ANNUAL BUDGET FOR THE CALENDAR YEAR 2024 OF THE PROVINCE OF DAVAO DE ORO AMOUNTING TO THIRTY SEVEN MILLION PESOS (P37,000,000.00) ONLY FOR PRIORITY EDUCATION PROJECTS IN THE PROVINCE OF DAVAO DE ORO"

WHEREAS, Ms. Eva Jean Licayan presented the proposed expenditures of the Special Education Fund embodied in the Annual Budget for the calendar year 2024 involving the amount of Thirty Seven Million Pesos Only (P37,000,000.00), which will be funded out of estimated Real Property Tax and it was deliberated by the Provincial Local School Board;

WHEREAS, the proposed expenditures embodied in the Annual Budget of Special Education Fund for the Calendar Year 2024 are based on the Provincial Local School Board Annual Investment Program CY 2024;

WHEREFORE, on motion for the adoption of the proposed income and expenditures by Ms. Grace V. Quintana and seconded by Engr. Norberto D. Manlangit; be it:

RESOLVED, to approve, as the Provincial Local School Board hereby approved PLSB Resolution No. 19- 2023 of the Special Education Fund Annual Budget for the Calendar Year 2024, appropriating the total amount of Thirty Seven Million Pesos (P37,000,000.00) only for priority education programs, projects and activities in the Province of Davao de Oro;
